The KTAM European Equity Fund may consider deploying currency derivatives to hedge against fx risks. This is up to the judgment of the portfolio manager given prevailing investment climate.

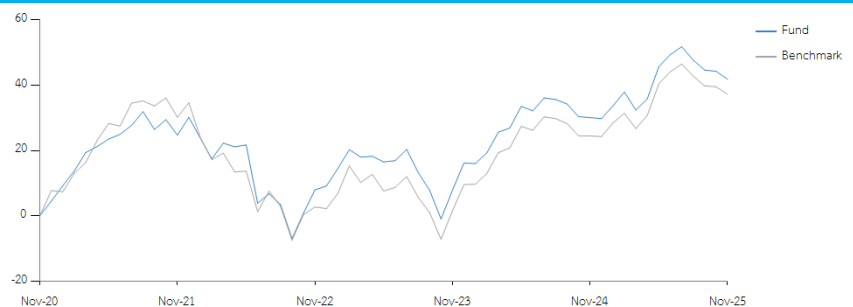

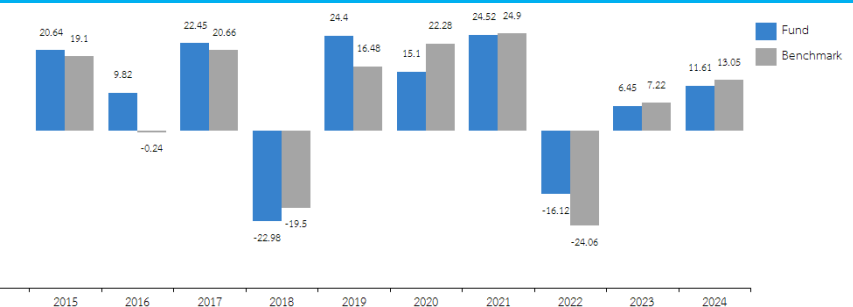


